## ***Guide for Hail Damage***

### **Which Hudson do you live in?**

You will want to verify in which municipality your property is located to determine whether your roofing or siding replacement requires a building permit. ### **City of Hudson Residents:**

Per municipal code 106-6 D, **the *City of Hudson* does not require or issue building permits, or provide inspections for the replacement of roofing, siding, gutters, windows and doors.** For your benefit, keep records of the date products were installed along with the make and model of the specific products.

### **Direct Sellers, Transient Merchants and Solicitors:**

Per municipal code 124, no person shall engage in direct sales within the City of Hudson without being registered for the purpose. Applications, license fees and background checks are required for each individual performing direct sales within the City of Hudson. ### **Wisconsin Uniform Dwelling Code:**
