Part F: MUNICIPAL CODE §207-11

§ 207-11. Annual collection license.

No person shall provide or operate any refuse or garbage collection service within the City of Hudson without first having obtained an annual license from the City Clerk's office.

- A. The annual license shall cover the period from January 1 to December 31 of each year.
- B. The annual fee for each collector's license shall be \$100 per year. No license shall be issued if the applicant is delinquent in payment of any taxes, assessments, forfeitures for violations of City ordinances, utility bills, or any other claims owed to the City. [Amended 3-12-2012 by Ord. No. 3-12]
- C. The City Clerk's office shall provide application forms which shall include the name and business address of each hauler, a description of each motor vehicle used by the hauler to collect refuse, the name and address of the hauler's insurance company and such other information as the Clerk may deem necessary to fulfill the purposes of this chapter.
